#### 772 SUPPORT FOR THE 2017 MENS HOCKEY WORLD LEAGUE SEMI FINAL Paper E/468/16

The report was introduced by Dan Buck, Head of Sport & Leisure, highlighting that it was currently the bidding season for major events to be held over the next 4 years.

In response to Members it was advised that:

- support for the track cycling world championships had generated approximately £2m worth of exposure for £100,000 investment;
- discussions were underway with England Hockey and the Tennis Federation as to capital developments at Lee Valley Hockey & Tennis Centre to enhance usage and to reduce the need for revenue funding in future to support major events;

- national governing bodies were aware of the Authority's focus on community engagement and were now expanding this element when seeking Authority support for major events; and
  - following success at the Rio Olympics England Hockey were actively seeking headline and tier 2 sponsors.
- (1) support for the event with a direct contribution from the Authority to the Lee Valley Leisure Trust of £76,500 for venue hire costs was approved.

### 773 DEVELOPMENT PROPOSAL FOR LEE VALLEY LEISURE COMPLEX Paper E/470/16A

The Chairman advised that following recent discussions with the local authority, paper E/470/16 had been amended.

- (5) that in parallel with taking the Development Investor route forward, that over the next 8 weeks officers assess the viability of an alternative proposal for the Picketts Lock site from the London Borough of Enfield was approved; and
- (6) a further report will be made on the outcome of the marketing exercise and to review the viability of the scheme before a final Member decision and legal commitments are made; and
